Association Rules 2012-13


P.L.A.C.E. was founded in January of 1998. We are an educational nonprofit 501c3 governed by a board of trustees and certified according to the statutes set by the state of California. P.L.A.C.E. supports itself on the contributions, grants, and endowments from those individuals and foundations concerned with creating a progress in Freudian and Lacanian analysis.

I- Global Structure and Functions

The association is divided into two main divisions: Adherents and Non-adherent.

- 1- An Adherent is anyone who attends the Sclinic.
- 2- A Non-Adherent is anyone who is an Auditor or Volunteer.
- **A– Adherents** are divided into two main positions:
- 1.1 **Trustees** = anyone who participates in the Sclinic and is voted in as a Trustee after a certain amount of work at PLACE.
- 1.2 **Participant** = anyone who participates in the Sclinic.
- a) An Adherent is anyone enrolled in the Sclinic.
- b) A Trustee who is no longer enrolled in the Sclinic has a grace period of six months, then is asked to step down to allow a participant to take their place.
- c) All adherents are entitled to the use of the infrastructure of PLACE. See Catalogue descriptive of courses, cartels, extension project, pass, scholarships, and work-study.
- d) On the successful accomplishment of a work and the *pass* at PLACE the title of A.P.: *Analyst of PLACE* may be awarded. This title is valid for two years and written into the books of PLACE on the achievement of the *pass*.
- e) Those caring to work through PLACE without working as an A.P. are welcome.
- f) All those who are not an A.P. of the association may be called 'non-analysts' or N.A.
- **B– Non-Adherents** are those who are not enrolled in the Sclinic. They may be friends, colleagues, auditors, donators, or volunteers of the association. Non-adherents may on a case by case basis engage part of the infra-structure of PLACE in writing a request to the secretary addressing the Trustees on the nature of their project and why PLACE should be involved.

The follow tree structures the sites of the association:



Current 2012-13 Tuition per Semester:

- \$ 1,100. Trustees (All Courses + Cartels+ Vote on General Assembly+ Summer Immersion)
- \$ 800. Participants (All Courses + Cartels + Attendance of General Assembly)
- \$ 450. Guests (Either One Course or One Cartel)
- \$ 0. Auditor (Can sit in on any Course, Cartel, General Assembly, or Immersion for one Semester)

Tuition may be paid all at once on registration or in installments after speaking with the secretary.
